

GSRA 100 Club Lottery Terms and Conditions

Object

1. The object of the GSRA 100 Club lottery (the “**lottery**”) is to raise funds to support participation in squash and racketball, including (without limitation) the provision of financial assistance with the cost of attendance at off island squash and racketball events (the “**object**”).
2. The proceeds of the lottery after the payment of prizes will applied to the object.
3. Allocation of funding in support of the above object will be at the discretion of the GSRA Committee or a sub-committee thereof established for that purpose.

Eligibility and Entry

4. Persons wishing to participate in the lottery must register by completing and returning a signed Lottery Club registration form to the GSRA Office.
5. Participation in the lottery is open to anyone over the age of 16 years who is present in Guernsey at the time of purchasing their ticket.
6. Participants may join the lottery at any time, but will be required to commit to participating in each remaining monthly draw.
7. For a cost of £5 per monthly draw, one lottery number will be allocated (one “**ticket**”) upon receipt of payment.
8. Participants will be notified of their lottery number and the same number will be used for all monthly draws in respect of each ticket.
9. Payment must be made by either a single annual payment per ticket in respect of each remaining monthly draw (e.g. a total of £60 for the full twelve draws) or by monthly standing order of £5 per ticket, to reach the GSRA by the 23rd of each month for inclusion in the next monthly draw.
10. No ticket will be eligible to win a prize in a monthly draw, unless payment has been received in respect of that monthly draw by the 23rd of the preceding month.
11. Participants may purchase more than one ticket. There is no maximum number of tickets that any one person may purchase.
12. All ticket sales will be final and no refunds will be made at any time.
13. By participating in the lottery, participants acknowledge and agree that their personal data may be processed and retained for the purpose of administering the lottery.

Prizes

14. Three prizes will be drawn each month.
15. Provided at least 50 tickets have been sold, the amount of the prizes will be 1 x first prize £60, 1 x second prize £40 and 1 x 3rd prize £25.
16. Once 100 tickets have been sold the amount of the prizes will increase to 1 x first prize of £120, 1 x second prize of £80 and 1 x 3rd prize of £50.

17. In the event of fewer than 50 tickets being purchased for any monthly draw, the amount of the prizes will be:

- 1 x first prize of 24% of the proceeds of ticket sales for that draw,
- 1 x second prize of 16% of the proceeds of ticket sales for that draw, and
- 1 x 10% of the proceeds of ticket sales for that draw.

Draws and Results

18. The lottery will run for twelve months with the first draw in October 2022 and the last draw in September 2023.

19. Each monthly draw will be made not later than the end of the first full week of each month using numbered balls.

20. The first number drawn will win the first prize, the second number drawn will win the second prize and the third number drawn will win the third prize.

21. If a number is drawn which has not been allocated (or is not eligible to win a prize) a redraw will take place until an eligible number is drawn.

22. The draw will take place in the presence of at least two GSRA Committee members, or nominated delegates, each month.

23. Results will be emailed each month to all participants and winners will be contacted by the GSRA to (a) confirm the amount of prize money won and (b) request confirmation of the account details into which the money is to be paid.

24. If, after reasonable efforts, a winner cannot be contacted within six months the prize will be cancelled and the amount of the prize will be treated as proceeds of the lottery to be applied towards the object.
